Dear Governor Cuomo:

I am pleased to provide you a copy of the Annual Report on Prompt Payment Interest for the State Fiscal Year 2015-2016. This report is prepared annually as required by Section 179-m(3) of the State Finance Law. The Report identifies the number and amount of interest paid when State agencies did not meet the statutory deadlines before interest was due to vendors, the number of days to process late payments, and the reasons for the delays.

In the 2015-2016 fiscal year, State agencies paid interest totaling \$1,462,835, representing a decrease of \$62,277 from the prior year. Our office consistently completed our voucher audit within the time allotted under the State Finance Law. In doing so we prevented \$375,525 in additional prompt payment interest charges that would have otherwise been owed.
