PS&T Longevity Lump Sum Payments for 1992 and 1993	Date August 25, 1993		

Chapter 74 of the Laws of 1993, which implements the Agreement between the State and the Public Employees Federation representing employees in the PS&T Services (05) negotiating unit and Rules and Regulations promulgated by the Director of the Budget provide for the continuation of the longevity Lump Sum Payment of \$1,250 or \$2,500 to certain employees.

These are the instructions for processing the payments for 1992 and 1993, which will be paid together in a single, separate check the week of September 20, 1993.

The following employees are eligible for the longevity LSP.

- 1. Employees in graded positions (grades 001-037)
 - a. Employees who were on the payroll on March 31, 1992 or March 31, 1993, (active or on leave with partial pay or on Workers' Compensation leave) in a position in the PS&T negotiating unit, who as of March 31, 1992 or March 31, 1993 had 5 or more years or 10 or more years of continuous service at a salary equal to or above the job rate, or maximum of the grade of their position on March 31

AND

- b. who did not receive a "Below Minimum" rating during rating periods ending between January 1 and December 31, 1991 and January 1 and December 31, 1992. Employees who were not rated during one of the periods will also receive that respective payment.
- 2. Employees in N.S. (grade 600) positions which were equated to grades

The rules authorize payment of the Longevity LSP to employees who occupied non-seasonal N.S. (grade 600) positions which were equated to grades in the PS&T unit on March 31, 1992 or March 31, 1993 who meet all other eligibility criteria.

NOTE: Employees who retired prior to March 31, 1992 or March 31, 1993 are not eligible for the longevity LSP for that year.

Continuous service as used in determining eligibility for the lump sum payment is paid service (including part-time annual-salaried service and sick leave at half pay) or time on Workers' Compensation leave or Military leave without pay.

In determining eligibility:

- 1. Employees who continuously occupied the same position without any break in service must have been at the maximum salary of the grade on April 1, 1987 to qualify for the 1992 5-year longevity; April 1, 1988 to qualify for the 1993 5-year longevity; April 1, 1982 for the 1992 10-year longevity; and April 1, 1983 for the 1993 10-year longevity. For employees who have had breaks in service, any service prior to the above dates during which the employee was receiving a salary equal to or in excess of the maximum can be counted towards the 5 or 10 year requirement.
- 2. Employees who received a performance advance to bring their salary to the Job rate on July 1, 1979 or July 1, 1980 who were active on the payroll for the entire period from April 1 to June 30, 1979 or 1980 receive credit for that 3 months.
- 3. Employees who occupied a higher grade position at any time in the past receive credit for all service during which they earned a salary which was equal to or above the maximum of the grade of the position which they occupied on March 31, 1992 or March 31, 1993.
- 4. Employees who were receiving a salary equal to or above the maximum of the grade who upon promotion to a higher grade received a salary equal to or above the maximum of the new grade receive credit for all service in the promotion position and the prior position during which they were receiving a salary equal to or above the maximum of the lower grade.
- 5. Employees who were promoted from a position which, subsequent to April 1, 1987 was reallocated, who were receiving a salary equal to or above the job rate of their former lower grade position and following the reallocation, their former and current positions are allocated to the same grade and their salary in the promoted position is at the job rate, receive combined credit for all service following the promotion and for all service in the previous position during which their salary was equal to or above the job rate of the lower grade.
- 6. Employees who were receiving a salary equal to or above the maximum salary of the grade whose positions have been reallocated, whose resulting salary was below the job rate of the new grade but whose salary on March 31, 1992 or March 31, 1993 was at the job rate, receive credit for all service subsequent to the reallocation and for all service in the position prior to reallocation during which their salary was equal to or above the maximum salary of the lower grade.
- 7. Former Institution Teachers whose positions were reclassified to Developmental Specialist and who were receiving a salary equal to or above the maximum salary of the lower grade, whose salary following reclassification was below the job rate of the new grade, but whose salary on March 31, 1992 or March 31, 1993 was at the job rate receive credit for all service subsequent to the reclassification and for all service prior to the reclassification during which their salary was equal to or greater than the maximum of the lower grade.

- 8. Employees who previously held the position of Pharmacist I who were receiving a salary equal to or above the job rate of grade 17, whose salary on promotion to the newly-established position of Pharmacist II fell below the job rate of grade 18, but whose salary on March 31, 1992 or March 31, 1993 was at the job rate of grade 18, receive credit for all grade 18 service subsequent to the promotion and for all service during which their salary was equal to or above the maximum of grade 17.
- 9. Institutions Teachers paid over 10 months (pay basis code 10M) are not on the payroll in July and August. However, these employees receive credit for a full year of continuous service if they were on the payroll for 10 months. Their service will be reduced only for periods when they were not paid between September 1 and June 30.
- 10. Employees who otherwise qualified but were on an approved leave of absence without pay or on a preferred list on March 31, 1992 or March 31, 1993 and who return(ed) from such leave between April 1, 1992 and March 31, 1993 or April 1, 1993 and March 31, 1994 respectively, are eligible for the payment. There is no minimum service requirement following the employee's return to active payroll status.
- 11. Demotion after March 31, 1992 or March 31, 1993.

Employees who were not eligible for the 1992 or 1993 payment become eligible if they return(ed) to a lower grade position between April 1, 1992 and March 31, 1993 or April 1, 1993 and March 31, 1994 respectively, in which they would otherwise have been eligible if they had been in the lower grade position on March 31, 1992 or March 31, 1993 and remain in the lower grade position for at least 6 payroll periods and

a. the promotion was temporary and the employee has been reinstated to his or her previous position or appointed to another lower grade qualifying position

OR

- b. the promotion was permanent, but the deomotion occurred
 - 1. in lieu of layoff
 - 2. voluntarily during the probationary period
 - 3. as a result of failure of a probationary period.

Employees demoted as a result of disciplinary action or who take a voluntary demotion from a permanent position after the completion of the probationary period are not eligible for the payment.

Determining Maximum Salaries

In 1980 and 1981 for all grades and 1986 and 1987 for grades 001-017 the job rates on the PS&T Salary Schedules were increased by an amount greater than the percentage increases. These increases do not affect eligibility for the longevity LSP for employees who were receiving a salary at or above the job rate prior to the effective dates of the new schedules and who advanced to the new job rate on the date they were next eligible for a performance advance.

Also, due to the percentage method of salary increases and rounding of the Salary Schedules, some employees who were at the maximum or job rate have at times received salaries that were slightly lower than the actual maximum or job rate. These employees are considered to be at the maximum and receive credit for all such service. Attached to this Bulletin is a list of the "Maximums" (Attachment A) which an employee must have been receiving in order to be considered to be at the maximum for April 1980, April 1979, April 1978, October 1977 and April 1977.

Amount of Longevity Lump Sum Payment

The longevity lump sum payment is a one-time lump sum payment which is included as salary for retirement purposes. It is also included in the calculation of overtime compensation (refer to "OVERTIME COMPENSATION", Part III, Page 1 of your Salary Manual). The amount of the longevity payment for 1992 is to be included in the calculation of overtime compensation that was earned from April 21, 1992 through April 19, 1993. The amount of the payment for 1993 is to be included in overtime compensation earned from April 20, 1993 through April 18, 1994.

As stated in Bulletin P-775, dated July 9, 1993, retroactive adjustments for overtime should be processed in Institution Period 14L, checks dated October 28, 1993 and Administration Period 15L, checks dated November 3, 1993.

The amount of the longevity payment is \$1,250 for 5 years at the job rate or \$2,500 for 10 years at job rate or a pro-rated amount, as appropriate, as described below.

- Employees who were full-time on March 31, 1992 or March 31, 1993 and full-time employees who were on leave with partial pay or on Voluntary Reduction in Work Schedule (VRWS) receive the full payment.
- 3. Employees who were part-time on March 31, 1992 or March 31, 1993 receive a pro-rated payment based upon their part-time percentage on March 31.
- 3. Part-time employees who, on March 31, 1992 or March 31, 1993, were on leave with partial pay receive a pro-rated payment based upon their regular part-time percentage prior to the leave.

Preparation for Payment

Agencies will receive listings of employees who OSC has determined are eligible for the longevity LSP. The listing will show separate columns and amount(s) for 1992 and 1993. The amounts shown are calculated using the employee's full or part-time percentage status as of March 31, 1992 and March 31, 1993. Review the listing carefully, especially for employees who are ineligible because they received "Below Minimum" ratings between January 1 and December 31, 1991 (for the 1992 payment) or January 1 and December 31, 1992 (for the 1993 payment).

Corrections to the preliminary listing should be submitted on the form which is attached to this Bulletin (Attachment B). (Duplicate this form if you need additional copies.) For employees who do not appear on the listing or for whom you disagree with the OSC determination, enter the correct amount for each year in the respective column for 92 LSP and 93 LSP on the form. If the employee is not entitled to either or both payment(s), enter '0' in the appropriate column.

You must also add employees in N.S. positions which are equated to grades who are eligible. If the equated grade is not listed on the Budget Certificate you must submit available documentation along with the correction sheet.

For employees who transferred between agencies, the agency where the employee was eligible on March 31, 1992 or March 31, 1993 is responsible for the respective payment.

These corrections should be submitted as soon as possible and <u>must be received</u> no later than Friday, September 10, 1993. Submit corrections to the following address:

PR-76 Transmittal

Please prepare a PR-76 Transmittal. Enter PS&T Longevity LSP at the top, leave the certification total blank, and sign the agency payroll certification. Submit the transmittal along with your corrections, if any. If a PR-76 Transmittal is not received in time for payment, the checks will not be released.

Payment and Withholding Taxes

The longevity payment will be paid in a single, separate check dated September 21, 1993. The checks and registers will be distributed the week of September 20. Deductions will be taken for Federal, State, New York City and Yonkers City taxes (the weekly tax table will be used if the payment is \$2499 or less and the biweekly tax table will be used if the payment is \$2500 or higher), Social Security/Medicare, retirement normal contributions, garnishees and Federal levies.

Fixed taxes submitted on either an AC-1040 form or through the On-Line Deduction Processing System will not be processed for this payment.

On the pay stub, the payment(s) will appear in the ADDTL SAL INFO block. The payment for 1992 will be identified with the code 'L92' and the payment for 1993 will be identified as 'L93'.

Payments to be made after the Special Payroll

Use transaction code LONG LSP to report the longevity lump sum payment for employees who will be paid by PR-75 instead of the Special payroll.

Remarks: If an employee is receiving payment for two years, list the amounts and part-time percentage, if applicable, for each year.

If LONG LSP is reported on the PR-75, a special tax routine will be used for the calculation of taxes.
