New Insurance Deduction Program for the Public Employees Federation

A new payroll deduction program has been established for employees who are members of the Public Employees Federation. The new program is PEF First Transamerica Life Insurance - Universal Life Insurance Program (code 392). Employees must have PEF dues (code 233) to participate in this insurance program.

The original deduction transactions will be submitted directly to the Office of the State Comptroller by PEF. The payroll agency is responsible for initiating this deduction only for the following conditions:

- 1. Transfer from one agency to another.
- 2. Reinstatement from a leave of absence without pay.
- 3. After reinstatement to the payroll after any other type of removal.

If deduction code 392 must be submitted on an AC-1040, enter the appropriate code in a "CODE" block and the amount to be deducted in the corresponding "AMOUNT" block.

Agencies entering transactions through the On-Line Deduction Processing System would enter this new insurance code on Screen Selection 5.

Employees may cancel this deduction by submitting a letter to PEF or to the Office of the State Comptroller requesting cancellation. The letter to OSC should be sent to:

Completed deduction authorization cards should be retained by the agency.

The new deduction code will appear on the check stub and also on the Salary Register in the miscellaneous column. A revised copy of the Pay Statement Codes for Executive and Legislative Employees is attached.
